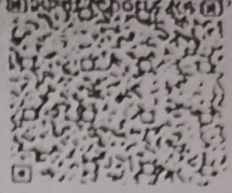

The preceding year: 20%, preceding two consecutive years: 25%, preceding three consecutive years: 35%, preceding four consecutive years: 45%, preceding five consecutive years: 50% of NCB on OD premium.
