3. EMI amount will be payable by the company in case the person on whose name the above plan has died due to any circumstances, this facility is available for use as per detailed T&C as per the T&C document available at <https://motorsathi.com/tnc>.
4. Coverage of EMI by the company in case the person on whose name the above plan is issued met with an accident and is hospitalized for more than 5 days. This is done as a compensation of salary loss of that month, this facility is available for use 2 times in a year.
5. If he/she has been relieved by the hospital within the time period, the service shall be rejected.
