<p><b>1) Towing of Vehicle on Accident</b></p> <p>In the event Covered Vehicle suffers an immobilizing break down due to a mechanical or electrical fault or an accident which cannot be repaired on the spot, Poorakh India will assist in making arrangement for the Vehicle to be towed to the nearest Authorised Service Center, using tow trucks in the cities and corresponding covered area where available. (Free Towing To and From upto 25 KM)</p>	<p><b>2) Tyre Change</b></p> <p>In the event Covered Vehicle is immobilized due to a flat tyre, Poorakh India will assist the Insured by organizing for a vehicle technician to replace the flat tyre with the spare stepney tyre of the Vehicle at the location of breakdown. Poorakh India will bear labour cost and round trip conveyance costs of the service provider. Material/spare parts if required to repair the Vehicle (including repair if that of spare stepney tyre) will be borne by the Insured. In case the spare tyre is not available in the covered Vehicle, the flat tyre will be taken to the nearest flat tyre repair shop for repairs and re-attached to the Vehicle. All incidental charges for the same shall be borne by the insured.</p>
<p><b>3) Arrangement of spare keys</b></p> <p>If the keys of the covered vehicle are locked inside the vehicle, broken, lost, or misplaced, Poorakh India (upon the request of the Insured) will arrange for the forwarding of another set from his/her place of residence or office by courier / in person by hand delivery to the location of the vehicle after receiving the requisite authorizations from the Insured with regards to the person designated to hand over the same to Poorakh India. The Insured may be requested to submit an identity proof at the time of delivery.</p>	<p><b>4) Extraction or Removal of vehicle</b></p> <p>In event of vehicle being stuck in a ditch/pit/valley, Poorakh India will make the arrangement to get the vehicle retrieved and towed to the nearest authorised service centre at no cost to the Insured. (Free Towing To and From upto 25 KM)</p>

Poorakh India will take charge of relaying urgent messages relating to the breakdown to the authorized workshop and/or service contacts. When requested, Poorakh India will relay urgent messages on behalf of the Insured to a designated person of their choice.

In the event Covered Vehicle runs out of fuel and hence is immobilised while on a trip, Poorakh India will assist Insured by organizing for a Vehicle technician to supply emergency fuel (up to 5 ltrs on a chargeable basis) at the location of breakdown. Poorakh India will bear labour and conveyance costs. The cost of the fuel will be borne by the insured.

<p><b>1) ) City Tax and Other Charges</b></p> <p>In case the vehicle is being towed from one state to another or from one city to another, any local tax or toll tax, like green tax in Delhi-NCR and etc. has to borne by Insured.</p>	<p><b>2) Adverse Weather</b></p> <p>On occasion of adverse weather conditions such as floods, heavy rain, thunder / lightening or other external factors may affect our ability to provide services and it may become physically impossible to assist you until the weather improves. During such times, our main priority will be to ensure that you and your passengers are taken to a place of safety; the recovery of your vehicle may not be possible until weather conditions permit.</p>
<p><b>3) Coverage</b></p> <p>The roadside assistance is a nationwide service provided to mobilize vehicle which has become disabled due to unexpected breakdown. While providing roadside assistance, we carry out temporary repairs and not regular maintenance which are normally carried out at authorized workshops.</p>	<p><b>4) Program Start Date</b></p> <p>The date of commencement of coverage under the program. The program start date will be after 7 (SEVEN) days from the program purchase date.</p>
<p><b>5) Program End Date</b></p> <p>The coverage end date of the program. The Roadside Assistance Program shall be valid for a period of 12 (twelve) months from the Program start date as mentioned in the program certificate.</p>	<p><b>6) Un-located or Unattended Vehicle</b></p> <p>In case of a breakdown, you must be able to provide us with the correct location of your covered vehicle. Incorrect or incomplete information may cause a delay in provision of our services. You or an authorized representative must be present with the vehicle at the agreed meeting place when we arrive. <p><b>7) ) Covered Vehicle is off road</b></p> <p>In case the covered vehicle is not on gazette, bitumen road and if there is a need to arrange special equipment (any equipment other than standard towing equipment), the charges of such equipment are not part of the roadside assistance program. <p><b>9) ) Accidental cases</b></p> <p>In cases where the police authorities have registered an FIR or are in a process of registering an FIR or are investigating a case or have taken possession of the vehicle, Assistance services can be activated only after Police authorities/courts have given a clearance to the vehicle / have released the possession of vehicle. In such cases it is the duty of the Insured to obtain such clearances. AWP can take handover of the vehicle only after clearances have been obtained and the Insured / Insured representative is available to provide appropriate handover of the vehicle to the towing representative from the police authorities.</p>	<p><b>10) External Factors</b></p> <p>We will take every effort to reach you once you make the call however the response time may vary depending on, among other things, the breakdown location of the vehicle and the general demand for roadside assistance at the time of your request is received.</p>

### Restriction of Coverage

#### Accidental Death:

#### Permanent Total Disability

It is strictly restricted to Permanent Disability due to accident, while the owner of vehicle driving the vehicle or occupant/pillion on the vehicle.

Coverage is applicable to persons with age up to 70 years.

### Coverage in Brief

If the Insured person meets with an accident and sustains any bodily injury during the period of insurance which directly and independently of all other causes result in death / permanent total disablement within 12 months from the date of accident resulting solely and directly from accident then the company shall pay to the insured the sum set in the schedule to the insureds persons' nominee or legal successor. ### Exclusions

### Claims Process / Documentation

Upon happening of any accident and/or injury which may give rise to a claim under this policy:

• You shall give the notice to Poorakh India Call centre no 7941050643 immediately and also intimate in writing to our policy issuing office. In case of Death, The claimant must notify the (Poorakh India Services Pvt. Ltd.) about the accident within 15 days from date of loss/accident in attached claim intimation form. In the event of loss of sight or amputation of limbs, written notice thereof must also be given within 15 days after such loss of sight or amputation. - Investigator will be appointed by insurer on receipt of claim intimation.
- All certificates, information and evidence from a Medical Practitioner or otherwise required by us shall be provided by you/claimant
- On receipt of intimation from you regarding a claim under the policy, we are entitled to carry out examination and ascertain details.
- Claim Form/Documents Submission

Documents required in Claims:

- 1.Certificate issued by Poorakh India Services Pvt Ltd.
- 2.Duly filled up claims form
- 3.Original F.I.R or F.I.R - Notarized/ Attested by a gazetted officer
- 4.Police Final charge sheet/ Court Final order - Notarized/ attested by a Gazetted Officer - if applicable
- 5.Spot Panchnama and Police Inquest report - Notarized/ Attested by a Gazetted officer, if applicable

4. Any other document as required by the Company to investigate the Claim or Our obligation to make payment for
5. In respect of fatal claims, the payment is to be made to the assignee named under the policy. If there is no assignee, the payment is made to the legal representative as identified by Succession Certificate
