<p>1) Towing of Vehicle on Accident</p> <p>In the event Covered Vehicle suffers an immobilizing break down due to a mechanical or electrical fault or an accident which cannot be repaired on the spot, Poorakh India will assist in making arrangement for the Vehicle to be towed to the nearest Authorised Service Center, using tow trucks in the cities and corresponding covered area where available. (Free Towing To and From upto 25 KM)</p>	<p>2) Tyre Change</p> <p>In the event Covered Vehicle is immobilized due to a flat tyre, Poorakh India will assist the Insured by organizing for a vehicle technician to replace the flat tyre with the spare stepney tyre of the Vehicle at the location of breakdown. Poorakh India will bear labour cost and round trip conveyance costs of the service provider. Material/spare parts if required to repair the Vehicle (including repair if that of spare stepney tyre) will be borne by the Insured. In case the spare tyre is not available in the covered Vehicle, the flat tyre will be taken to the nearest flat tyre repair shop for repairs and re-attached to the Vehicle. In the event Covered Vehicle runs out of fuel and hence is immobilised while on a trip, Poorakh India will assist Insured by organizing for a Vehicle technician to supply emergency fuel (up to 5 ltrs on a chargeable basis) at the location of breakdown. Poorakh India will bear labour and conveyance costs. The cost of the fuel will be borne by the insured.

<p>1)) City Tax and Other Charges</p> <p>In case the vehicle is being towed from one state to another or from one city to another, any local tax or toll tax, like green tax in Delhi-NCR and etc. has to borne by Insured.</p>	<p>2) Adverse Weather</p> <p>On occasion of adverse weather conditions such as floods, heavy rain, thunder / lightening or other external factors may affect our ability to provide services and it may become physically impossible to assist you until the weather improves. During such times, our main priority will be to ensure that you and your passengers are taken to a place of safety; the recovery of your vehicle may not be possible until weather conditions permit.</p>
<p>3) Coverage</p> <p>The roadside assistance is a nationwide service provided to mobilize vehicle which has become disabled due to unexpected breakdown. While providing roadside assistance, we carry out temporary repairs and not regular maintenance which are normally carried out at authorized workshops.</p>	<p>4) Program Start Date</p> <p>The date of commencement of coverage under the program. Restriction of Coverage

Accidental Death:

Claims Process / Documentation

Upon happening of any accident and/or injury which may give rise to a claim under this policy:

• You shall give the notice to Poorakh India Call centre no 7941050643 immediately and also intimate in writing to our policy issuing office. In case of Death, The claimant must notify the (Poorakh India Services Pvt. Ltd.) about the accident within 15 days from date of loss/accident in attached claim intimation form. In the event of loss of sight or amputation of limbs, written notice thereof must also be given within 15 days after such loss of sight or amputation. - Investigator will be appointed by insurer on receipt of claim intimation.
- All certificates, information and evidence from a Medical Practitioner or otherwise required by us shall be provided by you/claimant
- On receipt of intimation from you regarding a claim under the policy, we are entitled to carry out examination and ascertain details.
- Claim Form/Documents Submission

Documents required in Claims:

- 2.Duly filled up claims form
- 3.Original F.I.R or F.I.R - Notarized/ Attested by a gazetted officer
