In the event of loss of sight or amputation of limbs, written notice thereof must also be given within 15 days after such loss of sight or amputation. - Investigator will be appointed by insurer on receipt of claim intimation.

- On receipt of intimation from you regarding a claim under the policy, we are entitled to carry out examination and ascertain details.
