### Claims Process / Documentation

In case of Death, The claimant must notify the (Poorakh India Services Pvt. Ltd.) about the accident within 15 days from date of loss/accident in attached claim intimation form. In the event of loss of sight or amputation of limbs, written notice thereof must also be given within 15 days after such loss of sight or amputation. - Investigator will be appointed by insurer on receipt of claim intimation.
- All certificates, information and evidence from a Medical Practitioner or otherwise required by us shall be provided by you/claimant
- On receipt of intimation from you regarding a claim under the policy, we are entitled to carry out examination and ascertain details.
- Claim Form/Documents Submission

Documents required in Claims:

1. Certificate issued by Poorakh India Services Pvt Ltd.
2. Duly filled up claims form
3. Original F.I.R or F.I.R - Notarized/ Attested by a gazetted officer
4. Police Final charge sheet/ Court Final order - Notarized/ attested by a Gazetted Officer - if applicable
